Good afternoon, BCC And BCC affiliates. I hope you are having a wonderful Thanksgiving week. Last BCC meeting, we discussed a potential change towards strengthening the awareness and resources for the discretionary fund and I mentioned I'd follow up with an email. These funds are used at the discretion of clergy for the financial support towards the community which also includes members of the parish in a hard financial spot. We are under \$500 and around Christmas/winter time is when we see the most need, so we are a little low. This often goes towards things like phone and heating bills, portions of rent payment, gas and food, etc.

I was under the impression that every month, \$75 goes from the budget into the discretionary account. Marlene did not believe this was the case. Jeff Solas, any thoughts you or others could offer related to that? Unless someone knows differently, the only time discretionary account receives resources is from individual donations, which we rarely request. Even if it were \$75 a month, it still is a limit on one of the strongest avenues we have to assist members of the community and church directly.

One suggestion mentioned was to start a "Discretionary Sunday," which many churches do. Upon further reflection, I think this would good for us. Churches will take the open offering (loose cash and checks in the plate - anything designated like pledges, etc, is not open offering) on the first Sunday and place it in the discretionary account instead of budget. Most importantly, this also increases awareness so individuals know how to support one of our primary ways we directly support immediate need. When we look at 'loose plate' for the 2025 budget, we would just need to think of it as 3 Sundays out of 4 per month, with one going to Discretionary, and reduce expected budget from loose plate by 25%.

This would require a motion and approval by the BCC if the BCC wants this. If we do have a majority, I'd like to make that first request this Sunday since it is the first Sunday of December, and, the first spiritual day of the new year (Advent 1).

Additional thoughts or a motion? Even if a motion is made and votes cast, I think it appropriate to continue conversation with any thoughts or questions anyone has until moving to a vote. But, it is Thanksgiving week.

Treasurer Report: JS (8 Minutes)

2025 Budget: JS is starting the 2025 budget. Please send him any notes on where we should spend more or less money. COLA for 2025 is 2.5% and Sticky-Price number is 4%. So an increase somewhere between 2% and 5% would be good. JS followed this with some cool diagrams!

The numbers: This month had higher spending on the grounds, janitorial and website in pretty much all these cases that's just because of the lumpiness of these things. Plate is down again, we are hitting around 54%. But people who were giving via plate are now giving via pledge. That's a good thing I like that very much. Hopefully November and December will have more money in plate. That is what historically happens. We were a bit ambitious for our plate this year. So that's something we want to correct in our budget for next year.

MHC needs more money, they do WAY more than just coffee hour. Probably other ministries feel the same way. JS offered to reach out to ministries to ask what they think. MDM will send JS the list of ministries and the leads.

Plan going forward: JS thinks we could put more money in a CD or a high interest savings account. NJB, MDM and Darin Manica all get a 500% raise for 2025!!!! Thanks Fr T!

2024 Pledge Reports: Marlene had printed off the up to date giving for 2024. So we've been handing those out, we started last Sunday. You know, towards the end of the year people will do catch up on their pledges. So we we may see an increase as we get closer to the end of the year. We typically do

Trees vs Poinsettias for decorating during Christmas: For the last 3 years GM purchased the poinsettias for the sanctuary that the Altar Guild decorates, and last year it occurred to me. Maybe instead of buying 20 poinsettias, I could buy 12 poinsettias and a couple of trees that could be planted on the ground so that that could be something that we could do every year instead of just the poinsettias. People take home, and that's great. But you know they're they're not intended to be to last a long time. When it came up last year, we had questions about where would we plant them? Who would be responsible for planting and monitoring them? Is this something that we really want to do? Lot's of discussion followed and decision was made to not go forward with trees due to logistics. Poinsettias are beautiful if not long lasting. Tree idea tabled for future discussion.

Marlene's Raise: Marlene 10% pay increase beginning Jan 2025

The entire staff has received raises in 2023 or 20234 except Marlene. Some concern was brought up because the BCC did not have Marlene's pay rate available. JS looked at last few months and she got \$160, \$100 and \$200 so the 10% raise won't break the budget.

BBCR payment for Utilities: Non-potable water, Xfinity Mobile, United Power

MDM has put together a spreadsheet for phone, utilities, and non-potable water so we can figure out what BBCR owes. The last payment BBCR gave was for 2022. It was decided, to make things easier, that BBCR should cover non-potable water and StB should cover potable water. Tabled until December 2024 numbers are in and MDM can show both 2023 and 2024.

ACTION ITEMS:

MDM send 2023 and 2024 totals for utilities, phone and non-potable water to the BCC showing what BBCR owes

BBCR Loan from 2023: BBCR is discussing repayment of the StB loan given in 2023 for \$6900. The BCC decided that BBCR did not have to pay back the loan but now that BBCR has some money in the bank, they feel it is the right thing to do.

- Ministry Plan: Discuss REAL plan for talking about the ministries (more than once a year)
 - GSC wants to set up a schedule for promoting the ministries.
 - 1. Figure out how many ministries we have divided by 4, and on a quarterly basis go through and talk about them. We've got lots of new people and they don't have a clue about how to get involved.
 - 2. Some of this will be done via Realm.
 - 3. We also need to make the ministries more visible in church, even if they're going to be on realm. It's good that we remind the people at the church.
 - 4. Why don't we do a put it on the door going into the Sanctuary. Ministry of the week: If you're interested in this idea contact ministry lead. The next week we do the next one and once we get through everybody, we put it up again. It's just I forget things when they're not putting my face sometimes (GSC).
 - 5. REALM IS ALIVE IN 2025!!
 - 6. BCC will continue the conversation about how to get this done.

Discretionary Fund: (See email discussion at beginning of minutes)

What can we do to build up the fund?

So to give a background discretionary fund? It's under \$500 now. That will not last long with it being winter and it getting towards the end of the year. Many people are requesting help, whether it's utilities, food, and whatnot. In the budget, \$75/month goes to the Discretionary fund. Discretionary Fund is specific to myself and Bookie and is used to assist people who are in extra need.

NJB: It's a way that we serve the community in a way that Christ has taught us. I think that we need to not only emphasize, but to teach. That's 1 of the reasons we exist as a church. It's not to feed ourselves, Turkey. It's to feed it to others.

Holly Comforter has declared one week a month as Discretionary Fund Week. Do we do that and increase the monthly budgeted amount? Follow up will be done via email from Fr T. Amendment passed.
